

中材建设隶属于中国建材集团旗下的中国中材国际工程股份有限公司,已有六十多年的历史,注册于中国河北省唐山市,总部设在北京经济技术开发区,通过IS09001质量管理、IS014001环境管理和IS045001职业健康安全管理三体系认证,企业信用等级连续多年保持AAA级。

中材建设是一家集咨询、设计、供货、施工、运维于一体的工业工程总承包公司,是国家高新技术企业,具有国家工程总承包一级资质、对外经营权和进出口权。公司全面贯彻落实国家"走出去"发展战略和"一带一路"倡议,在全球50多个国家承建了200多个水泥生产线项目,是承建世界大型跨国水泥集团项目最多的中国工程企业,在国际水泥工程领域树立了良好的品牌形象和市场影响力,为中国水泥技术占领国际市场发挥了积极作用。

CBMI Construction is affiliated with SINOMA International Engineering Co., Ltd. under the China National Building Materials Group Corporation. With a history of over 60 years and incorporated in Tangshan, Hebei, China, CBMI Construction is based in Beijing Economic Technological Development Area. The company has passed ISO9001 quality management, ISO14001 en vironment management and ISO45001 occupational health and safety management, and the enterprise credit level was AAA for a number of years.

CBMI Construction is an industrial engineering EPC company engaged in counseling, design, supply, construction, operation and maintenance, a new high-tech enterprise, and has national engineering EPC level I qualification, foreign business right, import and export right. The company fully implements the national "reach out" development strategy and "Belt and Road" Initiative, and undertakes over 200 cement protection lines in over 50 countries. CBMI Construction is a Chinese engineering enterprise that has undertaken most projects of the world's big cement multinational corporations. The company has forged a good brand image and market influence in the international cement engineering field and plays an active role for Chinese cement technology to seize the international market.

中材建设主营业务为水泥工程项目总承包,具有完整的EPC总承包服务链,可针对不同客户需求及环境特点,在各种规模水泥生产线的工程咨询、设计研发、设备制造和成套、土建安装、生产调试、备品备件、售后服务和生产管理等方面,为客户提供"EPC+"个性化"总承包"集成服务。

近年来,中材建设积极探索和推进国际化、数字化、属地化、多元化、产业化发展战略,在建筑、冶金、电力、市政、环保和主营业务延伸等方面进行了有益的尝试,开发和推广了节能、环保、低排放的水泥生产项目的改造技术,以及余热发电、脱硫脱硝技术等。

With general contracting of cement project as its main business, CBMI has a complete EPC general contracting service chain, and can provide "EPC +" individualized "general contracting" integration service in the project consulting, design and R&D, equipment manu facturing and assembly, civil installation, production and commissioning, spare parts, after-sales service and production manageme nt etc. of various scales of cement production lines according to the different customer demands and environmental characteristics.

In recent years, CBMI has actively explored and promoted the internationalized, digitized, localized, diversified and industrialized de velopment strategies, has made beneficial attempts in building, metallurgy, electric power, municipal engineering, environmental protection and extension of main businesses etc., developed and promoted the reconstruction technology of energy-saving, environment-friendly and low-emission cement production projects and utilized cogeneration, desulfuration, etc.

目前中材建设90%以上业务集中在海外,遍布欧亚非美,客户资源主要集中在拉豪、西迈克斯、海德堡、老城堡等高端跨 国水泥集团,在国内外具有良好的品牌优势和美誉度。

中材建设累计水泥生产线签约合同总额超600亿元,承建了中国国内水泥行业大多数的水泥生产线重点项目,其中包括绝大多数外商投资项目和规模超过日产4000吨以上水泥熟料的生产线。

中材建设创造了多项业内第一,包括国内首条日产万吨水泥生产线、国内首条全套引进技术生产线、首条自行开发干法旋窑生产线、首条中外合资生产线、首个国际总承包模式"交钥匙"项目,并首次向欧洲国家出口水泥生产线成套设备等。

中材建设千余人的职工队伍可在全球十几个国家同时展开超100亿元人民币投资额、20多个项目的建设工作。

At present, over 90% of CBMI Construction's businesses are abroad and distributed in Europe, Asia, Africa and America. Its customers are mainly focused in high-end cement multinational corporations in LafargeHolcim, CEMEX, Heidelberg and CRH. The company has good domestic and overseas brand advantage and recognition.

CBMI's signed contract amount of accumulated cement production line was over RMB 60 billion. CBMI has undertaken most importa nt projects of cement production lines in China, including the majority of foreign-funded project and the cement clinker production line with daily output over 4,000 tons.

CBMI Construction has created many domestic first, including the domestic first cement production line with daily output of 10,000 tons of cement, domestic first production line of wholly imported technology, first proprietary dry rotary kiln production line, first Chinese-foreign joint venture production line, first international "turnkey" project, and first export of complement equipment of cement production line to European countries.

With more than 1000 employees, CBMI can construct more than 20 projects with an investment amount more than RMB 10 billion in dozen countries around the world simultaneously.

公司每月定期或不定期召开总经理办公会,并按照《中材建设有限公司章程》和《总经理工作细则》开展工作,对企业的生产、经营、管理等工作进行决策。

CBMI is a limited liability company established according to Company Law of the People's Republic of China, and establishes execut ive directors, supervisors and operation team according to Articles of Association for CBMI Construction Co., Ltd. The Company has professional committees under it, such as Safety Production Committee, Bidding Management Committee, Technical Committee, Risk Management and Internal Control Leading Group, Overall Budget Management Leading Group and Confidentiality Committee to manage and control the enterprise operation risks and supervise compliance operation of the enterprise.





安全管理制度建设

2020年,中材建设制定、修订了《生态环境保护节能减排管理办法》、《突发环境事件处理管理规定》、《安全技术交底制度》等安全环保制度,进一步完善了公司安全环保管理制度体系。

CBMI Construction gives priority to employee health and safety, and strictly observes laws and regulations such as the Law on Safety Production. With the safety outlook of "people orientated, observing redline and pursuing zero fatality", the companyef fectively advances safety integration, standardization and intelligence and strictly implements safety production responsibility. The company establishes the permanent safety management mechanism, implements safety product rules and curb hazard sources. Besides, it effectively inhibits incidents, safeguards safety production and creates a safe and stable environment for high quality development. In 2020, the company's accumulated safety input was RMB 20.63 million, and the company achieved 11.17 million safety work hours.

Construction of safety management system

In 2020, CBMI Construction formulated and revised the safety and environmental systems, such as the Measures for Administration of Ecological Environment Protection, Energy Saving and Emission Reduction, Provisions for Administration of Sudden Environmental Incidents and Safety Technology Disclosure System, and further improved the corporate safety and environment protection systems.





Efficient, low pressure loss, low nitrogen preheater system

The preheater system undergoes continuous optimization and achieves efficiency, low pressure loss, low nitrogen. The key performance indicators improve significantly and the outlet gas temperature of six-stage preheater is ≤ 260°C. The burned system resistance (six-stage preheater) is ≤ 4800Pa, kiln inbound material breakdown rate ≥ 95%, self-denitrification rate ≥ 50%. The device features less disp lacement of nitrides, higher energy availability and lower energy loss.

It ensures that the whole system is under effective closure and tiny negative pressure, and precisely inhibits dust powder and odor escape.


